 - XIX. To support and or aid to examine poor patients and to investigate them to provide medicine.
 - XX. To open found establish promotes, set up run maintain assist, finance support and or help in the setting up and for maintaining and for running by monetary gifts or otherwise, netras stadium playgrounds sport materials, sport dress, training and parks for public use sport s and games and other social welfare works and/or activities in chandauli and/or other places in INDIA.
 - XXI. To open found establish promote setup, run maintain, assist, finance, support and/or help in the setting up and/or maintaining and/or running institutions centers auditoriums and the like for running of welfare and other services to the public and to provide meeting room for socially useful activities and functions.

To do other public social, charitable objects a trust can do for the interest of public as a whole]

4. If any one or more of the objects specified in clause (3) of these presents are held not to be objects of a public charitable nature the trustees shall not carry out such objects as if the same are not incorporated in these present but the validity of the trust created by these present as a trust for public charitable purpose shall not be affected in any number.

5. That the final financial year of the trust shall be from date of registration to 5 October 2012 next year and subsequent financial year will be for a period of 12 months the 1st financial year of the trust shall close on 04th October 2013. Board of trustee shall have no liberty to change the accounting year except with the approval of income tax department or consequent to the change in income tax laws of the country.

 The accounts of the trust shall be audited as per requirement of the income tax Act. 1061 or any other statutory provisions thereof and the appointment of auditors shall be only in the meeting of trustees.

7. The trustees shall from time to time after meeting the expenses of and incidental to the management of the properties and of the trust decide the particular objects for which the income or corpus of the trust fund or the properties for the time being available shall be applied.

8. The Trustees may accept any donation or contribution in cash or in kind any person, firm, company, corporation, association institution or trust (including the settler or the trustee of any of them) for the furtherance of the objects of the or for any one or more of them upon such terms and conditions as they may in their absolute discretion think fit and which are not management of any other charitable or public institution on such terms as they think fit and may manage such institutions.

 without affecting the generality of powers and functions of the Trustee to manage and administer the trust the Board of Trustees shall have the following functions-

To borrow if needed the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their descision or agreement and to authorize two or more of the trustees to excute such documents deeds, papers, etc. as may be precessary in donnetion therewith.

II. to arrange for and/or athorize the signing or execution of any agreement, contract, instrument, document or any other paper or writing required to be signed or excuted on behalf of the trustees by any two of the trustees to be nominated in this behalf by the Board of trustees and to make the same effective and binding as if the said agreement contact instrument or document or paper or writing were signed by all trustees.

III. To appoint or make provision for the appointment of a subcommittee of trustees and/or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules and regulations as the trustees may prescribe.

IV. To authorize any one more trustees to hold any property or any fund any investment of the trust subject however to the terms of these presents in such manner and subjects to such terms and conditions rules and regulations as the Board of trustees may from time to time think fit and proper.


V. To such spend any portion of the corpus or the income of the trust fund for purchasing ang land and or constructing any building or buildings for and in the name of the trust for the purpose of carrying out promoting and / or executing any or all of the objects of the trust.

10. The trustees shall cause true and accurate to be kept of all moneys received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and/pupose of the trust as well as of all the assets, credits and effects of ther trust properties.

11. The trustees may invest the trust estate either in the purchase of immovable properties or of mortage immovable properties or in such manner as allowed by law as may be in force from time to time and to convert alter vary dispose or or transfer such investment from time to time provided that such investments shall not be made which are directly or or indirectly for the hencit of any person reffered to in sub-section (3) of section 13 of the income tax set 1961 or any subsequent amendments as may be made from time to time.

 That the fund of the trust shall be under the control of trustees and shall be invested in accordance with provisions of Indians trust act, 1882 and income tax act 1961.

13. If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the income tax act 1961, shall be carried over to the next year or years and spent in such subsequent year or years for the advancement of any of the objects of the trust.

- 14. The trustees shall be at liberty to sell such portion or portions of the movable or immovable properties forming part of the trust estate either by public auction or by private contract at such price or prices and on such terms and conditions relating to title or othersise in all respects as they may in their absolute description think fit and to rescind or very any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to excute all conveyance or other assurances and to pass valid and effectual receipts and discharges for all moneys received by them.
- 15. The trustees shall keep an account or accounts with any bank or hanks to operate such accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of such account or accounts and to authorize by appropriate resolution two or more of the trustees jointly appointed by the board of trustees in this abehalf to operate such account or accounts.
- 16. The trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the trust fund and may carry out repairs required to be done to the same and keep the same insured against loss or damages by fire and may incur all other costs, charges and expenses incidental to the administration and management of the trust estate and the properties for the time being belonging to the trust as they may in their absolute discretion think fit.
- 17. The trustees may manager or supervise the management of any lands hereditaments and premises for the time being comprised in the trust estate or any part thereof with power to erect pull down rebuild add to alter and repair houses and other buildings and to build draims and make roads and fences and otherwise to improve and develop and cultivate or cause to be cultivated all or any of the said lands hereditaments and premises and to insure houses and building against loss or damage by fire and/or other risksor to let lease make allowances to and arrangements with tenants agricultines and generally to deal with the said lands here determents, and premises as they may deem fit in their absolute discretion.
- 18. The trustees may appoint secretaries managers lawyers solicitors auditors, architects. Engineers, surveyrs, Comsultants, Gomastats or other employees for the purpose of managenets and supersision of the trust estate for collection of rents, effect and profits, for keeping the accounts and records and for other purpose of the trust.
- 19. The trustees may establish their office at such place or places and may change such places from time to time as they may think fit provided that the operation of trust shall be all over INDIA.

20. The trustees may demise the immovable property or properties for the time being and from time to time belonging to the trust either from year to year or fot any fixed term or for any term of years or on monthly tenancies at such rent and subject to such convenants and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.

21. The trustees shall have full power to compromise or compound all actions , suits and other proceedings and settle differences and disputes touching the trust estate and or thetrust properties and refer to ant such differences to disputes to arbitration and to adjust and settle all accounts relating to the trust estate and/or the trust properties and to do all other acts and things fully and effectually without being liable or answerable for any bonafide loss occasioned thereby.

22. The trustees may join Co-operate and amalgamate the trusts created by these presents or any portion thereof with any terms as they may in their absolute discreation think fit.

23. That if trust cease to function fot any reason and trustees want to dissolve the trust may be dissolved and in the event dissolve of trust, assets own by the trust will be transferred to the existing trust undertaking same type of charitable activities or having similar object as that of this trust.

24. The trustees may from time to time frame shemes and rules and regulations to carry out the objects of the trust affi for managing the affairs of the trust otherwise for giving effect to the objects and purpose of the trust and to vary the same from time to time as the trustees may in their discretion deem fit and proper.

 The receipts granted by the Trustees or any one or more of them for any moneys, stocks funds, shares securities or investments paid, delivered or transferred to them in exercise of the trust or powers hereof shall effectually release and discharge the persons or persons paying delivering or transferring the same there from and from seeing or from being bound to see the application thereof or being answerable for the loss or misapplication thereof.

26. The trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and restart any chairy or charitable institution to impose any condition or conditions to any subscription or / Wester Port 189 donation made by them and to earmark any portion of the trust property or income for any particular





- 27. The trustees may reimburse themselves and discharge our of the trust fund all expenses incurred by them in or about the execution of the trust or any of their duties under these presents including travelling expenses but will not be entitled to any remuneration.
- 28. All the trustees unless they voluntarily resign or otherwise decide shall continue to be the trustees during the term of their natural lives.
- The number of trustees shall be less than two and not more than nine.
- Any trustee may retire at any time without assigning any reason and without being responsible for any
 costs occasioned by such retirement.
- 31. The surviving or continuing trustees may notwith standing any vacancy in their board act as trustees provided however that if the number of trustees shall not except for the purpose of filling any vacancy act so long number is below the said minimum.
- Two trustees at a meeting shall form a quarum for any meeting of the the trustees.
- 33. the trustees for the time being shall cloct from amongst them one chairman and he shall hold office for years, unless he resigns refuses to act as chairman or otherwise ceases to be trustees
- 34. All proceedings and questions and matters arising at the meeting of the trustees shall be decided by a majority of votes and in case of equality of votes the chairman shall have a second or casting vote provided however that notwithstanding anything herein stated no question dealing with the disposal of the corpus of any of the trust properties and/or investment out of the trust corpus shall be decided except with consent of the chairman of the trust.
- 35. In case of difference of opinion between the trustees are equally divided in any matter the chairman shall have a casting vote.
- 36. A resolution in writing circulated amongst all the trustees and signed by a majority of the trustees present in India shall be as valid and effectual as if it had been passed at a meeting of the trustees duly convened and held.
- 37. notice of the meeting of the Trustees and all communications may be sent to the trustees at their addresses registered for the time being in the records of the trust.
- 38. All meeting of the trust shall be held at such place and at such time as the chairman of the trust shall decide from time to time.
- 39. A trustee who is anable to be present at a meeting of the trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be kip vote on the matter concerned.


